



# Town of Brian Head opens 'Alpine Creek Loop'

BRIAN HEAD — Oct. 6 marked the grand reopening of a hiking trail in Brian Head, called the Alpine Creek Loop. To celebrate this reopening, the Town Council of Brian Head organized a group hike, preceded by the ribbon cutting, and followed by a community barbeque.

Participants included both residents of Brian Head and tourists visiting the area. Hikers met at Town Hall at 11 a.m. They made their way down to the trail head to listen to introductory remarks from the Town Manager Bret Howser and Mayor H. C. Deutschlander, also called

# Local tobacco ordinance could be amended

**CEDAR CITY** — The Cedar City Council could vote tonight on amending the current ordinance related to specialty tobacco businesses. That subject was widely discussed during the Oct. 5 council meeting, at which City Manager Paul Bittmenn explained the proposed amendment to the ordinance.

'The proposed amendment is that to determine whether or not one of these shops is a tobacco business, the city would look at a couple of factors: the name of the business and how they advertise the business, and what they dedicate their sales

# Cedar High cheerleader qualifies for London trip

Like all of us, Victoria Beraja has plans to enjoy the coming of 2017 by celebrating the arrival of the New Year with friends. The big difference is that she hopes to be doing it in London, England.

Victoria, a sophomore at Cedar High School, is one of about 650 cheerleaders from across the United States chosen to represent the country at London's famous New Year's Day Parade. If her current fundraising efforts are successful to pay for the trip, she'll be flying across the pond on Dec. 26 for a week-long English adventure.


It started when Victoria and her teammates from the Cedar High cheerleaders competed in Logan at a camp earlier this year. The Varsity Spirit program judged cheerleaders at over 5,000 summer camps and narrowed their list down to their All-American team. Victoria and fellow Cedar cheerleader Sadie Langston, also a sophomore, were the only two invited to be part of the London trip. Victoria said Sadie isn't going, but if Victoria's mother Lisa Cox has anything to say about it, her daughter will be.

"She was awarded a pink ribbon for being most spirited," Cox said. "She's really looking forward to meeting other All-American girls and performing in such a big stage, as well as seeing London's sights.'

Victoria said meeting other girls, as well as the trip itself, has her very excited. She was "so happy to get the pink ribbon and be named All-American. I've love cheerleading since I was a little girl, and this is a dream come true for me.'

The cost is extensive—about \$3,350 for flight, hotels, food, etc. Lisa has been actively recruiting sponsors to help with those costs—sending out letters and thank you cards to local businesses and individuals who are helping with donations. Victoria is known as the "flyer," the one who climbs to the top of formations when cheerleaders do routines. She said the theme of this year's London parade is "Lights, Cameras, Action," as it will pay homage to the wonders of film and television.

"This is the 30th year we've been able to bring these talented cheerleaders and dancers to London,

# **Road to Recovery** 5K on Oct. 15


**CEDAR CITY** — The Horizon House Mentor Group has put together a 5K race for Oct. 15, open to the community, in support of recovery.

the participants for showing up to support the opening. He also thanked the Town Council for pushing the project along and the trail crew for their hard work in cleaning up the trail. With that, he cut the ribbon for Alpine Creek Loop, and the hikers began the first hike of the new trail.

The hike itself is only about two miles, with the option for a longer four-mile hike, called the Medium Loop, or the 10-mile Scout Camp Trail. The trail starts just past Brian Head Town Hall, goes for about a mile before looping around and ending right back where it begins. The total hiking time was approximately 45 minutes, bringing the hikers back to the Town Hall just in time for a barbeque lunch hosted by the Town Council.

Cecilia Johnson, treasurer for the Brian Head Town Council, said that the trail opening was designed to promote community involvement. This is just the first event of what will become an annual tradition, with a new activity each fall to bring community members together.






# Haunted Homestead activities

- If a word is underlined, that means the amendment is adding the word to the
- If a word has a line through it, that means the word is currently in the Constitution and the amendment is deleting it.
- If a word is neither underlined or lined through, that means the amendment is keeping the word in the Constitution.

#### Constitutional Amendment A

AMFNDS:

#### **ARTICLE IV, SECTION 10**

Be it resolved by the Legislature of the state of Utah, two-thirds of all members elected to each of the two houses voting in favor thereof:

Section 1. It is proposed to amend Utah Constitution, Article IV, Section 10, to read: Article IV, Section 10. [Oath of office.]

All officers made elective or appointive by this Constitution or by the laws made in pursuance thereof, before entering upon the duties of their respective offices, shall take and subscribe the following oath or affirmation: "I do solemnly swear (or affirm) that I will support, obey, and defend the Constitution of the United States and the Constitution of [this] the State of Utah, and that I will discharge the duties of my office with fidelity."

Section 2. Submittal to voters.

The lieutenant governor is directed to submit this proposed amendment to the voters of the state at the next regular general election in the manner provided by law.

Section 3. Contingent effective date.

If the amendment proposed by this joint resolution is approved by a majority of those voting on it at the next regular general election, the amendment shall take effect on

#### **Constitutional Amendment B**

AMFNDS:

#### **ARTICLE X, SECTION 5**

Be it resolved by the Legislature of the state of Utah, two-thirds of all members elected to each of the two houses voting in favor thereof:

Section 1. It is proposed to amend Utah Constitution, Article X. Section 5, to read: Article X, Section 5. [State School Fund and Uniform School Fund -- Establishment and use -- Debt guaranty.]

- (1) There is established a permanent State School Fund which [shall consists] consists of [revenue from the following sources]:
- (a) proceeds from the sales of all lands granted by the United States to this state for the support of the public elementary and secondary schools;
- (b) 5% of the net proceeds from the sales of United States public lands lying within this
- (c) all revenues derived from nonrenewable resources on state lands, other than sovereign lands and lands granted for other specific purposes;
- (d) all revenues derived from the use of school trust lands;
- (e) revenues appropriated by the Legislature; and
- (f) other revenues and assets received by the [fund] permanent State School Fund under any other provision of law or by bequest or donation.
- (2) (a) The <u>permanent State School Fund [principal]</u> shall be [safely] <u>prudently</u> invested by the state and shall be held by the state in perpetuity.
- (b) Only [the interest and dividends] earnings received from investment of the

permanent State School Fund may be [expended] distributed from the fund, and any

<u>distribution from the fund shall be</u> for the support of the public education system as defined in Article X. Section 2 of this constitution.

(c) Annual distributions from the permanent State School Fund under Subsection (2)(b) may not exceed 4% of the fund, calculated as provided by statute.

 $[\frac{1}{2}]$  (d) The Legislature may make appropriations from school trust land revenues to provide funding necessary for the proper administration and management of those lands consistent with the state's fiduciary responsibilities towards the beneficiaries of the school land trust. Unexpended balances remaining from the appropriation at the end of each fiscal year shall be deposited in the permanent State School Fund.

[<del>(d)</del>] (e) The permanent State School Fund shall be guaranteed by the state against loss

- (3) There is established a Uniform School Fund which [shall consist of revenue from the following sources] consists of:
- (a) [  $\underline{\text{interest and dividends}}$  ]  $\underline{\text{money}}$  from the  $\underline{\text{permanent}}$  State School Fund;
- (b) revenues appropriated by the Legislature; and
- (c) other revenues received by the [fund] <u>Uniform School Fund</u> under any other provision of law or by donation.
- (4) The Uniform School Fund shall be maintained and used for the support of the state's public education system as defined in Article X, Section 2 of this constitution and apportioned as the Legislature shall provide.
- (5) (a) Notwithstanding Article VI, Section 29, the State may guarantee the debt of school districts created in accordance with Article XIV, Section 3, and may guarantee debt incurred to refund the school district debt. Any debt guaranty, the school district debt guaranteed thereby, or any borrowing of the state undertaken to facilitate the payment of the state's obligation under any debt guaranty shall not be included as a debt of the state for purposes of the 1.5% limitation of Article XIV, Section 1.
- (b) The Legislature may provide that reimbursement to the state shall be obtained from monies which otherwise would be used for the support of the educational programs of the school district which incurred the debt with respect to which a payment under the state's quaranty was made.

Section 2. Submittal to voters.

The lieutenant governor is directed to submit this proposed amendment to the voters of the state at the next regular general election in the manner provided by law. Section 3. Contingent effective date.

If the amendment proposed by this joint resolution is approved by a majority of those voting on it at the next regular general election, the amendment shall take effect on

#### Constitutional Amendment C

AMENDS:

#### **ARTICLE XIII, SECTION 3**

Be it resolved by the Legislature of the state of Utah, two-thirds of all members elected to each of the two houses voting in favor thereof:

**Section 1.** It is proposed to amend Utah Constitution, Article XIII, Section 3, to read: Article XIII, Section 3. [Property tax exemptions.]

- (1) The following are exempt from property tax:
- (a) property owned by the State:
- (b) property owned by a public library;
- (c) property owned by a school district;
- (d) property owned by a political subdivision of the State, other than a school district, and located within the political subdivision;
- (e) property owned by a political subdivision of the State, other than a school district, and located outside the political subdivision unless the Legislature by statute authorizes the property tax on that property;
- (f) property owned by a nonprofit entity used exclusively for religious, charitable, or educational purposes:
- (g) places of burial not held or used for private or corporate benefit;
- (h) farm equipment and farm machinery as defined by statute;
- (i) water rights, reservoirs, pumping plants, ditches, canals, pipes, flumes, power plants, and transmission lines to the extent owned and used by an individual or corporation to

irrigate land that is:

- (i) within the State: and
- (ii) owned by the individual or corporation, or by an individual member of the corpora-
- (j) (i) if owned by a nonprofit entity and used within the State to irrigate land, provide domestic water, as defined by statute, or provide water to a public water supplier: (A) water rights; and
- (B) reservoirs, pumping plants, ditches, canals, pipes, flumes, and, as defined by statute, other water infrastructure:
- (ii) land occupied by a reservoir, ditch, canal, or pipe that is exempt under Subsection (1)(j)(i)(B) if the land is owned by the nonprofit entity that owns the reservoir, ditch, canal, or pipe; and
- (iii) land immediately adjacent to a reservoir, ditch, canal, or pipe that is exempt under
- (A) owned by the nonprofit entity that owns the adjacent reservoir, ditch, canal, or
- (B) reasonably necessary for the maintenance or for otherwise supporting the operation of the reservoir, ditch, canal, or pipe.
- (2) (a) The Legislature may by statute exempt the following from property tax: (i) tangible personal property constituting inventory present in the State on January 1 and held for sale in the ordinary course of business:
- (ii) tangible personal property present in the State on January 1 and held for sale or processing and shipped to a final destination outside the State within 12 months; (iii) subject to Subsection (2)(b), property to the extent used to generate and deliver
- electrical power for pumping water to irrigate lands in the State; (iv) up to 45% of the fair market value of residential property, as defined by statute; (v) household furnishings, furniture, and equipment used exclusively by the owner of that property in maintaining the owner's home; and
- (vi) tangible personal property that, if subject to property tax, would generate an inconsequential amount of revenue.
- (b) The exemption under Subsection (2)(a)(iii) shall accrue to the benefit of the users of pumped water as provided by statute.
- (3) The following may be exempted from property tax as provided by statute:
- (a) property owned by a disabled person who, during military training or a military conflict, was disabled in the line of duty in the military service of the United States or
- (b) property owned by the unmarried surviving spouse or the minor orphan of a person
- (i) is described in Subsection (3)(a); or
- (ii) during military training or a military conflict, was killed in action or died in the line of duty in the military service of the United States or the State; [and]
- (c) real property owned by a person in the military or the person's spouse, or both, and used as the person's primary residence, if the person serves under an order to federal active duty out of state for at least 200 days in a calendar year or 200 consecutive days[-]; and
- (d) tangible personal property leased by the State or by a political subdivision of the State.
- (4) The Legislature may by statute provide for the remission or abatement of the taxes of the poor

Section 2. Submittal to voters.

<u>The lieutenant governor is directed to submit this proposed amendment to the voters</u> of the state at the next regular general election in the manner provided by law. **Section 3.** Contingent effective date.

If the amendment proposed by this joint resolution is approved by a majority of those voting on it at the next regular general election, the amendment shall take effect on January 1, 2017.



# Just Wear Your Baby

often get calls from frantic and desperate parents. "How do I get my baby to take a nap?" "How do I get my baby to stop crying?" I always respond with "wear your baby." Often the best way to help a fussy baby is to wear them. They are used to being close to mom. They could hear mom's heartbeat and smell her for nine months. It is going to take a little while for a baby to become accustomed to the

outside world.

Baby wearing has been around since the beginning of time... although the technique and styles that we use today are new. With the ability to scavenge for

food made difficult with a baby in tow, cave women used their natural instincts to create carriers for their infants. With hands free, it made hunting for food easier, with the added benefit of being able to take baby with them to nurse when needed.

We are not cave people; however, there are still extensive benefits to babywearing. Research has shown that newborn babies that are worn for a few hours during the day are happier, cry less and soothe easier than babies that are not worn. Kangaroo care, or wearing baby skin to skin with a caregiver, is routinely practiced in NICUs. Babies who are able to take advantage of

kangaroo care are able to regulate blood sugar levels, body temperature and their breathing and heart rate faster and easier than babies don't.

Toddlers benefit from babywearing as well. When a toddler is sick, they want to be near their caregiver. The easy solution is to wear your baby. You can complete tasks hands free while caring for your toddler. Being worn also allows bonding to take place while your little one is learning about their environment.

There are many types of carriers to choose from. Some of these carriers will last from newborn up to a toddler. Other carriers are intended for a specific development stage and size of an infant.

space and floor space (to) in the business," Bittmenn said. "We're hoping that this will capture more of those shops that we think might be tobacco shops but we couldn't capture under the old ordinance."

There is also a provision that clarifies the grandfathering of tobacco specialty businesses. The provision explains that if a tobacco specialty business meets all the requirements for obtaining a location and a license, that license will not be revoked if a business of any use specified in the separation requirements moves in near the tobacco business after it has been established.

Some businesses have already established themselves and acquired business licenses in Cedar City after meeting all the separation requirements. However, some businesses are located in places that probably would not be approved under the current ordinance. Bittmenn said this is part of the reason for the amendments, as well as difficulties determining how much of a business's gross profits come from tobacco products.

According to the city's current regulation, a retail specialty tobacco business is one that has 35 percent or more of its gross sales coming from tobacco products.

"We haven't had the ability to audit whether or not 35 percent of their gross sales comes from tobacco products," Bittmenn said.

Councilmember Fred Rowley asked Bittmenn about the reason for the agricultural separation requirement. Bittmenn said that language was pulled from state statute, but the reasoning for this particular regulation is unknown. Rowley also brought up the concern of one of the tobacco specialty business's income going into the owner's pocket as a way of keeping the gross sales from tobacco products under 35 percent.

Bittmenn explained as long as a CPA certifies the business's records and the business does not have a reference to tobacco in its name or advertising, under this proposal the business would not be a tobacco specialty business.

Rowley inquired about regulating certain drugs as well as tobacco, particularly a drug called "pink" (a synthetic opioid), which is being sold in some tobacco specialty businesses. Bittmenn said this problem has been encountered before, but it is difficult to regulate drugs like "pink" due to the fact that new drugs are created quite often. He further explained that the state will probably take up regulating and prohibiting "pink," but until it is specified as a prohibited substance it cannot actually be prohibited.

Rowley asked who specifically would be responsible for checking businesses and determining whether or not they are tobacco specialty businesses and if they are complying with the ordinance.

Heidi Baxley, a member of the ICPC, clarified for the council that tobacco is regulated through the Health Department.


# Local author Vickers celebrates publication of first children's book

# Tax assistance program opening new site in Cedar City

**CEDAR CITY** — Every year at Southern Utah University, students of the accounting department prepare hundreds of free tax returns for the community as part of the Five County Association of Governments Volunteer Income Tax Assistance program (VITA).

"We had a very successful tax season this year with over 600 returns processed," said Professor Robin Boneck of SUU. "We anticipate even more next year."

Starting in February 2017, a new VITA site will be opening in Cedar City where community members can have their taxes prepared for free.

"It is a great service that VITA and SUU provide every year," said Steven Bradbury, Mortgage Operations Manager of State Bank of Southern Utah. "We are excited to join with the Five County AOG Community Action Partnership and do our part to support our community." The site will be located at the new SBSU branch at the south end of town, 1322 S. Interstate Drive, which opened on Sept. 20 of this year.

The goal of VITA is to help low-to-moderate income individuals and families receive all the credits they're entitled too, specifically the Earned Income Tax Credit. The EITC is a tax credit for people who work, but don't earn high incomes. Workers can reduce their tax to zero and then receive a refund of the remaining credit. This means potentially increasing the effective wage of qualifying workers by more than two dollars per hour.

Four out of five qualifying Utah citizens claim their EITC each year, which means 20 percent of people who qualify aren't receiving money they are owed. By having IRS certified volunteers prepare taxes, community members save money by filing for free and are more likely to receive credits due to them.

The VITA program is able to continue each year because of the generosity and dedication of its volunteers.

"My first year volunteering, I was able to help a family of four who made \$12,000 a year receive a

refund of \$8,000," said Richard Glass, a seven-year veteran VITA volunteer. "Over the next few years, I watched them prosper, and that's why I love what I do."

All volunteers are trained and certified for free by the IRS to an advanced level. No previous tax or accounting experience is necessary. 

# **Remote Viewing**

few months ago a friend brought a book over to my house and said, "I have to be realistic and recognize that I probably will not read this. But you might. You may have it." So I gladly took it and put it in the stack of non-fiction books that this great literary group I belong to might like to read some day. That stack of books is pretty high, actually, but the thing that made this book different is that I know the author. And he is a really cool guy—witty, obviously smart, cheerful in demeanor, and not at all reluctant to state his opinion on things.

So I took the book to one of our meetings and a participant gushed, "I know that book! It is amazing, quite unlike anything I've ever read." When I told him that the author is an acquaintance of mine who lives in this town, his enthusiasm and excitement sold the others and the book moved to the top of the stack.

I'm talking about "Reading the Enemy's Mind" by Dr. Paul H. Smith. The sub-title reads, "Inside Star Gate, America's Psychic Espionage Program." Since I can't say it any better than this myself (because I don't quite understand it, actually), here is what the book jacket has to say: "From behind the cloak of U.S. military secrecy comes the story of Star Gate, the project that for nearly a quarter of a century trained soldiers and civilian spies in extrasensory perception. Their objective: to search out the secrets of America's cold war enemies using a skill called 'remote viewing."

Starting in 1983, Paul was a part of this unit for the rest of the decade, involved in many of the national-security crises of the twentieth century. This ESP technique was used in hostage situations, investigating bombings and weapons testing, uncovering spies, and more stuff that sounds like a good nail-biter of a movie. The secrets were finally de-classified, the program mothballed by the CIA, and Paul felt free to write a book about it.

All I can say is he has the most amazing memory on the planet or he kept incredibly detailed notes on a daily basis. I mean, can you remember the name of every individual you met 20 years ago, how hot it was, and what you had for lunch? Well, I don't know about that last thing, but the material is to detailed that there is a gripping sense of reality that makes you feel intimately involved in each experience.

Paul retired from the Army Intelligence Unit as a major, but is still involved in remote viewing as president of Remote Viewing Instructional Services, Inc. He will speak to the Cedar City Arts Council Literary Group on November 2, 7:00 p.m., in the Library in the Park. He will bring his electronics, talk about remote viewing itself, and answer questions about the book and his career.

# Why there can never be a perfect book/movie adaptation

o matter how much I love both books and movies, I've come to the conclusion that they can never truly love each other.

This is a rather disheartening realization, given the fact that at least 50 percent of all the movies coming out of Hollywood at the moment seem to be book adaptations ("The Girl on the Train" and "Middle School" this week alone). Not all of those adaptations will be bad, of course – "The Godfather" and the original "Jurassic Park" are both fantastic movies, in

some ways outshining the books upon which they were based. Even in arguably successful adaptations, such as "The Lord of the Rings" movies, "The Princess Bride," and "Gone Girl," the two feel like fundamentally different creatures.

In a very real way, they are. In order to make an excellent novel into an excellent movie, you often have to change it to the point where it no longer feels very much like the novel.

Streamlining is, of course, the most immediate necessity – as "Game of Thrones" has proven, the content of a single novel is enough to supply an entire season of a show, rather than just a novel. Those small, intimate scenes that may very well be your favorite parts of a story are often the first on the chopping block.

Secondly, the things that make an excellent book rarely if ever make

an excellent movie. Books are more internal, bringing you directly into the heads of the characters and letting you experience their thoughts and feelings. In the Harry Potter series, for example, we felt every moment of worry, grief and hope as if we were right there with him.

Movies, however, are all about visuals. A good actor or actress can communicate a character's feelings without a word, but that requires both an excellent performer and a director willing to let a quiet scene linger on meaningful looks and

a story from one medium to the other profoundly changes it, no matter how respectful the adaptor is. Even Gillian Flynn, who wrote both "Gone Girl" and the script for the movie adaptation, talked about how she had to reshape her story in the process.

Sometimes, that re-shaping is a blessing. Even those who don't love the movie adaptation of "Forrest Gump" agree that the book is a vastly inferior muddle. "Hannibal," though far from a perfect movie, fixed the absolute disaster of an

ending author Thomas Harris forced on the novel.

Other times, however, even good adaptations can be a stab in the heart for book fans. Readers of "The Hunger Games" series still complain bitterly about how the movies largely jettisoned the books' social commentary to focus on the love triangle, which is

exactly the same things the villains did in the book. On a smaller level, Harry Potter fans will never forgive the "Goblet of Fire" movie for ignoring the word "calmly" when delivering one key line.

I will continue to love books, and I will continue to love movies. I will, at times, even love movies based on books. But I think it's time I give up the dream of seeing the books I love breathed into full, complete life on the silver screen. The very nature of the two mediums makes it impossible.



shifts in expression. Even then, those scenes are interspersed with grander visuals, whether they are beautiful, sweeping vistas or action scenes either great or small.

Out of necessity, even the exact same moment will feel differently between the two mediums. A movie can capture the swinging arc of a hand coming to slap another face, frame it in stillness so it comes across as a shock, where a book would focus on the emotions leading up to the hit and the aftermath that follows. Bringing



his past week I had the enjoyable honor of taking my Grandma to the Tuachan Amphitheater to see "The Hunchback of Notre Dame." It's the story of Quasimodo, the misunderstood, but heartfelt hunchback. Without any real spoilers, I want to talk about things that spoil our confidence and our happiness.

We think our silence will protect us, but it only creates a sanctuary of suffering. Of course, and unfortunately, Quasimodo wins the contest. How often do we let the world, friends, family, or even ourselves, define who we are and our self-worth by only our mistakes, or even our differences? Words can be like rotten tomatoes hurled at our hearts and dreams. It needs to stop and it starts with you.

If you choose to attend the Feast of Fools, it's easier to become the King of Fools. Don't let your past mistakes and regrets turn you into the King of Fools anymore. Stop beating yourself up and setting fire to your future with the flames of your past. Stop being a hunchback and fight back. You have better places to be and better things to do—out there.

Out there, beyond the walls of 'woe is me' and the dungeons of disappointments lies your own court of miracles. You have talents and gifts that only you can give the world to make it a better place. Don't wait to find your sanctuary. Create it inside your mind heart. Before the sun sets on one more dream or tear, make a new commitment to person inside of you waiting to break free. Today is a good day to try.

# Preparing for Winter: It's right around the corner

Fall is in the air and winter right around the corner. While enjoying this time of year, it's also the time to start thinking about a few must-doitems to prepare your yard, ATVs and boats for the upcoming cold weather.

Start with your yard--experts say to aerate. Cooler temperatures make it an ideal time to give your lawn access to more oxygen and water, as well as fertilizer. Aeration reduces the thatch in your grass, improves drainage and also loosens the soil.

If you have trees, rake the leaves after the fall. Don't wait too long. Wet leaves from rain and morning dew can stick together and form a mat that cuts off nutrients and can also breed

Fertilize seems like something you would do in the spring, but did you know that you should be fertilizing in the fall too? Put your lawn to bed for the winter with the food it needs. Consult a lawn care expert to make sure you use the right kind of fertilizer, in the right quantities for where you live.

The time to start getting ready for a weed free lawn is just before winter sets in. Weeds, like all plants. Weeds are most vulnerable right now. Now is also a good time to repair dead patches in your lawn. The heat of summer takes a toll on your lawn. Get help from a lawn care professional to help determine what the issue is and how you can fix it.

Late fall is the time to plant bulbs in preparation for the spring.

Before freezing temperatures set in for the winter, make sure to drain all of your sprinkler and irrigation lines. Water in the lines freezes and expands breaking the pipes or irrigation

If you have an ATV, whether it's a four wheeler or side by side, there are winter precautions to consider.

'Now is a good time to service them," said Laci Werner, owner and manager of D and P Performance in Cedar City. "Use fuel stabilizer in the gas tank or plan on starting your machine and letting them run for three to five minutes every two weeks during the winter months and unhook the negative cable to the

Fuel stabilizer should also be used in lawn mowers, tillers and gas powered weed eaters. It's not a bad idea to start and run them periodically during the winter as well.

If you have a boat or wave runners, Chuck



Vanacore, owner of High Desert Mobile Marine Service, has some advice.

"Many people don't realize that even a boat kept in a garage needs to be winterized, especially the newer boats," he said. "Fuel systems, internal parts, fuel injectors need to be stabilized and cleaned during the winter months to avoid costly repairs come springtime. Manifolds, engine valves, engine blocks, outdrives and fuel systems need to be readied for the winter."

Vanacore went on to say, "Bottom line is you can't just drain the water and not expect expensive repairs when you're ready to use them next spring. Call a professional to protect your investment and to winterize your boats and watercraft."

As much as we hate to admit it, winter is on its way.

# Precept Study of Genesis series continues






