



# One arrested, one still at large after violent Cedar City jewelry store heist

The break-in was fast and violent — glass shattered, a man was beaten, and \$70,000 in jewelry vanished before sunrise in Cedar City.

Police arrested 47-year-old Eric Drexel Resma on Sunday, July 27, after he and an unidentified suspect allegedly broke into Clark & Linford Jewelers on North Main Street and attacked the store owner with a crowbar-style weapon during the burglary.

According to the affidavit filed in

support of the arrest, Resma drove the getaway vehicle while his accomplice smashed through the glass door and began stuffing a military-style camouflage backpack with jewelry.

"The vehicle pulls up to the front of Clark and Linford Jewelers a second male (unknown at this time) gets out of the passenger side of the vehicle and comes to the front door of the business and breaks the front door glass," charging documents state. "He then enters the Jewelry store through the broken door."

The store owner, who lives in an apartment above the shop, heard the crash and ran downstairs to confront the

intruder.

"He is hit with the crowbar type weapon and thrown to the ground," charging documents state. "The owner gets back up and is hit again."

Wounded but not deterred, the owner ran outside and leaned into the suspect vehicle to try to identify the driver. Resma allegedly hit the gas with the man still clinging to the car. The victim managed to free

himself before the vehicle sped off. Shortly after the break-in, a Southern Utah University police officer spotted the SUV driving without lights and attempted a traffic stop. The license plate was partially covered with a pair of underwear, according to police. The driver — later identified as Resma refused to stop and sped off. Meanwhile, the store owner got into his own vehicle and began searching the area. He eventually spotted the suspects heading south on Interstate-15 and followed them while contacting law enforcement. During the pursuit, he saw the vehicle slow briefly to toss a camo backpack out the window — a key piece of evidence later recovered

by officers.

Inside the backpack, officers found stolen jewelry with price tags still attached, along with small store display fixtures from Clark & Linford.

The chase ended when the suspects crashed on a frontage road along southbound I-15 — described in charging documents just off Exit 30, near Pintura. Both men fled on foot.

Officers found Resma hiding nearby; the second suspect escaped and remains at large.

"We still have officers following some leads," Cedar City Public Information Officer Sgt. Kirk Lovell said Thursday. Inside the crashed vehicle, officers recovered additional jewelry, methamphetamine, a glass pipe, a crowbar, and a sledgehammer. The storefront and display cases sustained more than \$1,500 in damage, police said. Resma, who investigators say drove across three states to commit the crime, was booked into the Iron County Jail on felony charges of aggravated burglary, aggravated assault, theft, drug possession, and fleeing police. Officers have requested he be held without bail, citing a high risk of flight.

## Cedar City couple arrested for drug sales around children, firearms in home

A Cedar City couple is facing felony charges after allegedly selling meth in front of their children and keeping drugs and guns where toddlers could reach them. Brandon James Tweed, 30, and Marjorie Susan Tweed, 37, were arrested July 28 after the Iron/ Garfield/Beaver Narcotics Task Force allegedly conducted several undercover drug buys and searched their home. Both were booked into the Iron County Jail on two counts of distribution of a controlled substance and two counts of possession of a dangerous weapon by a restricted person, all second-degree

felonies. They also face multiple counts of child endangerment, a third-degree felony — six counts for Marjorie Tweed and four for Brandon Tweed.

According to charging documents filed in 5th District Court, agents executed a search warrant at the couple's home after receiving information from a "reliable source" that meth, drug paraphernalia and two firearms were inside the residence.

Prior to the search warrant, affidavits detail multiple controlled drug buys over several months between the Tweeds and a confidential informant.

In one operation conducted in May, agents used a recorded wire to purchase 5.7 grams of methamphetamine from the couple inside their home. Audio captured during the transaction revealed young children were allegedly present at the time.

"Small children could be heard on the recorded wire during this buy and were present while Brandon and Marjorie were selling narcotics," the affidavit states.

Later that same month, agents arranged a second purchase through the same informant and again used a wire to capture the exchange. This time, investigators say Brandon Tweed drove to California, returned to Utah with a half-pound of meth, and reportedly sold it to the task force with

The rise of the Gog of Magog Alliance was warned about more than 2,600 years ago by the prophet Ezekiel when a coalition of nations would attack Israel. The leader of this coalition was named Gog,

the ruler of Magog (Ezekiel 38:1). The military forces of the three most powerful members of the Gog of Magog alliance are now present in Syria putting their joint military forces right on Israel's northern border. This is where Ezekiel said the invading force will come from (Ezekiel 38:15; Ezekiel 39:2). Is this a coincidence? Probably not because never in history has such an alliance been formed. Now many of Israel's enemies are stationed directly to Israel's north, even while the governments of Turkey, Iran, and Syria may be in transition while they evaluate their options following the fall of the Asad regime in Syria. Ezekiel also says that Israel's enemies will say: "Those people are far away from the Lord, so now he has given their land to us!" (Ezekiel 11:15); "Come, let us wipe out Israel as a nation. We will destroy the very memory of its existence" (Psalm 83:4); "Let us seize for our own use these pasturelands of God! (Psalm 83:12); "The lands of Israel and Judah will be ours. We will take possession of them. What do we care!" (Ezekiel 35:10); and "The mountains of Israel have been given to us" (Ezekiel 35:12-13). Ever since the rebirth of Israel in 1948, the daily headlines have restated these Bible verses with many of Israel's Muslim neighbors claiming the land of Israel for themselves, showing little regard for the citizens of Israel or for the prophecies of the God of Israel in the Bible. With the downfall of the Asad regime and the regime leaders fleeing to Russia, new political and historical alignments are forming, especially since the U.S. nighttime bombing of Iran's nuclear facilities. The rise of a United Europe is predicted in the Bible in Daniel chapter 2 and

7 and Revelation 17. According to Daniel a ten-nation alliance of weak and strong nations will arise, with

some parts as strong as iron while other parts will be as weak as clay (Daniel 2:42). We see the beginning

of this alliance in the European Union which is a coalition of weak and strong nations struggling to stay together. Since its inception, the EU has been an odd collection of governments, economies, currencies and militaries. From the Schuman Declaration in 1940 to the Treaty of Lisbon in 2007, the rise of the EU has been marked by a struggle to agree on important issues including arguments over a single currency (the United Kingdom and Denmark opted out), disagreements over how to handle debt crises such as the Greek bailouts, disputes over open borders (the Syrian refugee crisis), the United Kingdom leaving the Union (Brexit) and foreign policy dispute (the Russian-Ukraine war). Each step along the way, the EU has struggled to survive.

This volatility makes it more likely that the EU is an early phase of the alliance that Daniel described. It's the mirror image of the revived Roman Empire the Bible says will appear in the last days (Daniel 2:40-43, 7:23-24). It's made up of weak and strong nations (Daniel 2:42). It's divided against itself (Daniel 2:41) and the effort of these nations to come together and strengthen themselves is volatile and unstable (Daniel 2:43) especially since some of its members (not Germany) have recently voiced support for an independent government for Gaza (possibly to include Hamas).

We also see the rise of the beginnings of global government which the Bible says will rule the world politically (Revelation 13:7), religiously (Revelation 13:8) and economically (Revelation 13:16-17) in the last days. This worldwide government will rule over "all people, tribes, and languages" on the face of the earth (Revelation 13:7). Its authority will be so complete that no one will be able to buy or sell anything without its permission (Revelation 13:16-17). For centuries, a true global government was impossible, but today, world leaders meet to openly discuss the possibility in the World Economic Forum led by Klaus Schwab in their annual meeting in Davos bringing together chief executives (by invitation only) from over 1,000 member companies, select politicians, academic representatives, NGO's, religious leaders, and media ostensibly to discuss and solve international problems. Have you or your elected representatives been invited? Do you know about it? Look it up on: en.wikipedia.org/ wiki/World\_Economic\_Forum. Come back next week to stay informed.

#### Measles & pertussis showing up in Southwest Utah

– The Southwest Utah Public Health

Department (SWUPHD) is alerting our residents that unusually high cases of measles and pertussis have been confirmed recently in our district, which covers Washington, Iron, Kane, Beaver, and Garfield counties. "Measles is extremely contagious," says Dr. David Blodgett, SWUPHD Director and Health Officer. "Since we are only aware of cases from positive lab tests, it is likely that there are more infections and exposures in our community that we don't know about. If you are unvaccinated then you are at risk of getting the disease if you are exposed, which can happen up to two hours after an infected person has left an indoor space that you enter."

"We are also concerned about a rise in pertussis cases," Dr. Blodgett continues. "Also known as whooping cough or the 'hundred-day cough', this disease is also very contagious and can cause severe complications for infants and children. We urge parents to make sure their kids are up to date on their immunizations. These illnesses used to take a heavy toll on children before vaccine science was developed and we don't want them to make a comeback."

All known cases of measles and pertussis in Southwest Utah are investigated by SWUPHD surveillance staff with efforts made to alert close contacts and reduce the spread in the community. Both diseases are vaccine-preventable; all recent confirmed cases of measles and most pertussis cases were in unvaccinated individuals. All 4 known measles cases and 2 pertussis cases live in Iron County, while 30 pertussis cases are in Washington County with one child hospitalized.

Measles, one of the most contagious infections, is an airborne virus that causes a high fever, cough, and runny nose, followed by white spots in the mouth, then a red rash that can cover the entire body. Symptoms start a week or two after exposure. While most cases will recover at home, measles can cause severe diarrhea, breathing problems, brain swelling, blindness, and even death. Over 100,000 people, mostly unimmunized children, die from measles worldwide every year. The United States has seen the most cases this year since measles was officially eliminated in 2000. To find out how protected you are by vaccination according to your age, visit swuhealth.gov/measles. If you suspect that you or a family member has measles, call your healthcare provider for instructions before going in person.

Pertussis (whooping cough) is a highly contagious respiratory disease caused by a bacterial infection. Common cold-like symptoms start 1-3 weeks after exposure, but coughing fits can follow that last up to 10 weeks. These fits can be followed by a "whooping" sound as the person inhales and can result in vomiting,

fatigue, sleep loss, and fractured ribs. Infants in their first year are at higher risk of complications and may have difficulty breathing instead of coughing. Pertussis vaccines work most of the time, and vaccinated people who still get sick will have symptoms that are generally milder.



## SCAM ALERT: Fraudulent Text Messages **Targeting Utah Motorists**

**SALT LAKE CITY** – The Utah State Tax Commission's Motor Vehicle Division (DMV) is warning the public about a fraudulent text message circulating in Utah that falsely claims the recipient has an outstanding traffic ticket and

threatens enforcement and legal actions if immediate payment is not made. A picture of the text message is below.

Scammers commonly use these deceptive tactics to pressure individuals into making payments without verifying the legitimacy of the claim. How to Protect Yourself:

- Verify before paying If you receive a suspicious notice regarding a traffic ticket or any other DMV related matter, contact the Utah DMV directly at 801-297-7780 to confirm its authenticity.
- Do not respond to the text message Avoid clicking any links or calling any phone numbers listed in the fraudulent messages.

## Iron County Commission Meeting

The IT Department reported a healthy budget, despite minor equipment issues. The department handles around 330 work orders a month. Key efforts include staying current with legislation and working on two major compliance projects:

- Data privacy updates due by December, with UAC support.
- Cybersecurity, including multi-factor authentication, in response to a recent regional ransomware incident.

A financial update on performance was given: \$14 million collected since January, with \$2.3 million for Iron County. Interest earnings are up, including \$1.3 million from the PTIF and over \$500K from Morton investments. Outstanding taxes are at \$1.8 million.

The office has supported the county fair and taken on new responsibilities for personal property assessments. Recent audits found only minor issues.

The Commissioners then gave reports. Commissioner Robinson discussed efforts to address speeding on Camera Mountain roads, including traffic counters and increased patrols. He also gave an update on prairie dog trapping in Parowan Valley.

Commissioner Cozzens shared that he recently underwent emergency surgery for multiple pulmonary embolisms but has fully recovered and returned to work.

A major item involved a proposed \$500 easement from Enbridge Gas to install a high-pressure line under the Quichupa channel near Hwy 56. Commissioners raised concerns about restrictive terms that could limit future maintenance or upgrades to the stormwater system.

They also noted the offer undervalued the land compared to recent appraisals. The commission tabled the item and asked the county attorney to revise the agreement to better protect the county's flood control rights and ensure fair compensation.

The commission addressed a tax processing error that diverted 2024 solar revenues away from the redevelopment agency, preventing a \$694,289 incentive payment to the developer.

To correct this, they approved reducing the company's 2025 taxes by that amount, formalized the fix through a settlement agreement, and established related mitigation payment letters—preserving the original 15-year incentive structure.

Commissioners also discussed requiring agricultural grazing under future solar projects to promote dual land use, possibly tying it to future tax incentives.

All resolutions were approved, resolving the issue and setting a framework for future solar developments.

The commission wrapped up with approvals, acting as the Community Development and Renewal Agency, for settlement and mitigation agreements with Appaloosa Solar One LLC.

The most in-depth discussion came during the Board of Equalization session, reviewing greenbelt rollback appeals from BZI Innovations and NKM Family Trust. Both were denied for missing deadlines and lacking active agricultural use.

BZI had developed an 800-acre industrial park, and despite plans for future grazing, the county noted state law requires two years of active ag use. With paved roads and no fencing, the properties no longer qualified. The commission upheld the decision to remove greenbelt status.

The commission approved a \$53,789 state grant to remove invasive species like Russian olive and tamarisk from Cole Creek using low-impact methods. This marks the start of broader water optimization efforts.

They also approved several personnel changes, including sheriff's office promotions, new hires in building and zoning, and a road maintenance role. The meeting ended with a brief closed session with legal counsel.

#### Cedar City Council Meeting

During reports, Council Member Wilkey raised concerns about overgrown weeds blocking sidewalks at Lund and 1600 North, including near the fire station and Cedar Reserve townhomes. He stressed the need to clear paths for foot traffic. An update was also given on the Canyon View High School drainage project, which is on track for

completion before school starts August 13.

A large part of the meeting focused on water infrastructure. The BLM well project was completed, producing 1,400 gallons per minute—considered decent for the area, though officials had hoped for more. Water quality results are pending, and production may improve in spring due to winter recharge.

An annual economic report highlighted Iron County's growth, with the population at about 66,000 and Cedar City at 42,000. Manufacturing makes up roughly 10% of jobs, with activity in plastics, packaging, aerospace, food, and rail. The year included 24 responses to state economic requests and outreach to 16 new industrial projects.

In 2024, 721 occupancy permits were issued, bringing in around 2,200 new residents. Eight manufacturing projects have committed to the area, including a new plastics facility creating 71 jobs and a \$100 million expansion from another company.

Retail growth continues with new grocery and restaurant options, including WCO Foods, Discount Tire, Wing Stop, Seven Brothers Burgers, and Jersey Mike's. The report also stressed the value of partnerships with local colleges for workforce development and noted tourism brought nearly a million visitors and two million overnight stays, boosting tax revenue.

The meeting included a presentation on Southern Utah University's economic impact and community partnerships. SUU is Iron County's largest employer with 2,687 staff, and 70% of its students are from Utah—most of whom stay in the state after graduating.

They approved the consent agenda, including new appointments and naming the trail along Industrial Road the Fort Cedar Railroad Trail.

#### IRON COUNTY <u>GOVERNMENT RECAPS</u>

A proposal was presented to expand the Iron Springs Inland Port project area to include more Cedar City properties. Two items were considered: a resolution to start the expansion process and a review of which properties to include.

Council members voiced concerns about possible unfair advantages for new businesses, especially along Cross Hollows Road, where existing businesses have already invested in infrastructure. Clarification was given that inland port incentives would focus on industrial and corporate development, not retail, with tax financing aimed at broader infrastructure improvements.

A local developer spoke about ongoing needs for rail infrastructure at the Lund Avenue industrial park, where a large company has purchased land for future development.

The council approved both the resolution and the property inclusions, with four votes in favor and one against. Future development agreements will still require separate approval.

The council approved a change allowing the city engineer to approve variances to engineering standards without needing council approval. Members supported the shift, noting such decisions are best made by professionals, but requested easier online access to the standards.

An airport grant agreement was also approved for \$546,988 in runway maintenance, fully funded by the FAA. The project includes sealing, crack repair, and painting, with work already awarded and a signing deadline of August 8.

The council approved poll worker appointments for the August 12 primary and November 4 general elections. The workers are experienced volunteers trained by the county. Council members asked about the selection process and were told these individuals have served in past elections.

his wife present.

"Marjorie was also present when agents purchased the half pound of meth," and again, "small children could be heard on the recorded wire," charging documents state.

The final operation began when agents received a tip that the couple had drugs and firearms inside their home. It was at that time, officers began surveillance of the residence.

Because of the reported presence of firearms, agents waited until Brandon Tweed left in his truck to take him into custody away from the home. After his arrest, Brandon Tweed told investigators that his wife and children were still inside the house.

"He stated post Miranda that he didn't have much drugs at home and had 2 firearms in a hall closet, with one being in pieces," the affidavit states. While agents continued surveillance, they saw Marjorie Tweed leave the residence carrying what appeared to be a large lunch bag — apparently headed to work — before returning a short time later. During her absence, officers observed a toddler in the window. A subsequent search of the home confirmed that two toddlers had allegedly been left inside alone.

One of the children, authorities noted, is nonverbal and has autism, raising serious concerns about access to dangerous items found inside. "One child being non verbal with autism... could easily access the math (sp) and paraphernalia which were hidden in the bathroom," the affidavit states.

Agents executed the warrant once Marjorie Tweed returned and exited the home. Inside the master bedroom, they reportedly found 14 grams — or roughly half an ounce — of methamphetamine, along with multiple used needles and drug pipes hidden behind a mirror. Investigators said the bathroom setup allowed a child to easily reach the drugs

"These items could easily be reached by a child by climbing on the toilet and then onto the counter," the affidavit stated.

Agents also recovered a .22-caliber revolver stored on the top shelf of a hallway closet and a disassembled 9mm pistol on a middle shelf within reach.

Authorities asked the court to hold both without bail, citing public safety risks and flight concerns. Investigators wrote that Brandon Tweed "has ties in California and could be a flight risk if released. Marjorie Tweed, they noted, "could flee the jurisdiction due to having family out of town and could potentially hide and evade police and the courts."

#### Stop Raising Taxes

Did you receive your property tax notice? It's not a surprise anymore, but multiple tax increases are once again being forced upon our people. Annual tax increases are now the norm, not the exception. It's disheartening, the disconnect between elected leaders and citizens continues to grow and those who are least fortunate are most negatively impacted by this insatiable government appetite. We are averaging nearly two tax increases per year! Over the past eight years, Iron County, Utah, has faced a relentless barrage of tax increases—13 in total, by conservative estimates. These high tax proposals, originating from various local governmental jurisdictions, have sparked heated debates about the role and size of government in our community. While information from government is not very easy to find or decipher, it appears that of these roughly 17 proposals, only five went to a public vote. Four were resoundingly rejected by the people, with only the RAP sales tax managing to pass. The remaining 12 were decided solely by political leaders, bypassing the will

of the electorate. This pattern raises a troubling question: are our leaders forcing unwanted tax burdens on the citizens of Iron County?

The evidence is stark. With the exception of the RAP sales tax, every tax increase subjected to a public vote has failed, suggesting that the majority of these measures lack

vote has failed, suggesting that the majority of these measures lack popular support. Yet, our leaders have pressed forward, extracting hundreds of millions of dollars from residents' pockets. This has fueled a significant expansion in the size and scope of government, far outpacing the rate of inflation or population growth. Such unchecked growth is not only unsustainable but also misaligned with the values of the overwhelming majority in our community.

Remarkably, not a single tax cut has been proposed in any city, town, or any other political subdivision in Iron County over the same period. This one-sided approach to fiscal policy is alarming. How many tax increases will it take before Iron County mirrors the high-tax, high-regulation environment of states like California? For conservatives, who champion smaller government, this trend is contrary to core principles. Even moderates, who prefer maintaining the status quo, must find this relentless push for bigger government disconcerting. Liberals may support expanded government, but the lack

of public consent for these tax hikes should give everyone pause. The consequences of these policies extend beyond local budgets. Iron County's tax and regulation environment plays a critical role in decisions about where people and businesses choose to locate. As President Donald Trump and Governor Spencer Cox advocate for lower taxes and reduced regulations to strengthen America's position in the global economy, our local jurisdictions seem to be moving in the opposite direction. This divergence undermines efforts to make Iron County a less attractive destination for families and companies alike. Businesses seeking competitive environments may look elsewhere, and residents may feel squeezed by rising costs of living, threatening the economic vitality of our region. It's time for a change. Jurisdictions in Iron County can and should lead the way in reducing taxes and regulations, fostering an environment where businesses thrive and residents keep more of their hardearned money. The alternative—continuing down the path of unchecked government growth—risks transforming our community into something unrecognizable, a place where bureaucratic overreach stifles opportunity. We cannot afford to let government jurisdictions located in Iron County become another cauThe power to change course lies with us, the citizens. We must hold our elected leaders accountable and demand they prioritize the will of the people over the expansion of government. Reach out to your county commissioners, mayors, city council members, school board members, and other officials. Tell them to stop raising taxes and to focus on policies that promote economic freedom and opportunity. Let them know that the people of Iron County reject the trajectory toward a high-tax, high-regulation future. We can do better. By embracing fiscal restraint and reducing the burden on our residents and businesses, Iron County can set an example for the rest of the nation. But time is running out. If we don't act now, the creeping tide of tax increases will erode the very qualities that make our community unique. Contact your elected officials today and urge them to change course before it's too late. Remember, balancing a budget does not generally include a bailout by taxpayers every year. Balancing a budget means working with what you have, not taking more. Jurisdictions in Iron County should strive to follow conservative principles including working with what you have, being honest about what we stand for, and respecting the will of the people.

ears ago, we decided to plant all sorts of native trees and shrubs in our yard to attract wildlife. And the nice thing about that decision is that it really works. We have over a dozen kinds of birds that regularly visit, or actually live on, our small half acre. We also have dozens of pollinators ranging from hairstreak butterflies and dusky skippers, to bumblebees and hummingbirds. What we didn't count on, all those years ago, were the deer. As the years come and go, I have called them all sorts of unprintable names.

Once it got so bad that they completely defoliated (and ended up killing) three young fruit trees only weeks after they were transplanted. My wife Kathy laughs at my frustration. "Deer are wildlife too," she reminds me. "And we planted this yard for wildlife, didn't we?"

Of course, she is right. But the story of Bambi in our back-yard has recently taken on a different twist. He actually lives here now. Well, I should say that her name is Faline (the name of Bambi's girl-friend), because she doesn't have antlers. I recently found her next to a young apple tree early in the morning before the sun was up. This isn't

unusual. When deer visit, they tend to come when it is dark so the neighborhood dogs don't see them. So I expected the same behavior from this young doe. But then hours passed and she hadn't left. Two days later and she is still here. Kathy crowded her out of the yard a while ago, but she just came back. Our next plan involved calling the office of natural resources (DNR). They were helpful but admitted that there wasn't much they could do. Some deer, they said, just like living in town. And, in fact, there are quite a few in our extended neighborhood. If you have an outside dog or a tall fence, you may not even know about the problem. Cats won't work. Deer aren't afraid of them. My advice to other homeowners is to encircle your young trees and shrubs with chicken wire or some other protective barrier, at least until they get big enough to handle the feeding damage. Don't worry about the leaves that disappear from established plants. They are used to being nibbled on by wildlife and will grow back just fine. It's the young plants that need the most protection. We are not the only place that has a problem with large mammals. Covotes have overtaken many

cities - including large cities

where you wouldn't expect

them. Los Angeles has dozens (maybe hundreds) of them. Racoons and even bears occur all over populated areas in America (we have racoons in Cedar City). Not long ago a bull moose walked into Salt Lake City and had to be airlifted (by helicopter) out of town. We are fortunate to live in a place where many wild species are still fairly common close to civilization. It helps to remember that living in such a wonderful place sometimes requires compromise.

## CALIFORNIA CONDORS - A SIGHT TO BEHOLD

hese birds are rescued from the brink of extinction. These magnificent birds are once again soaring through Utah skies.

California condors are among the largest and rarest birds in the world, and you can find them soaring over the red-rock cliffs of southwestern Utah. They have been seen recently up Cedar Canyon, just 20 miles from Cedar City. The population now numbers more than 500 birds, with over half of those flying free in the wild. Nearly 350 condors in the monitored population are free to fly in southern Utah. Both adults and juveniles are known to roost on ledges of the southern Utah red rock.

The condor is one of the largest flying birds in North America. With a wingspan of nearly 10 feet—and a body that's four to five feet long—the condor is the size of a small car. In flight, they're like a small aircraft. These birds are breathtaking. They can reach speeds of 50 miles per hour when soaring and sometimes travel up to 200 miles a day in search of food.

Up close, the condor's unique appearance adds to its charm. Adults have bald, pinkish-orange heads and a distinctive white triangle pattern on the undersides of their jet-black wings. Younger condors are generally a dull black with grayish heads. Their coloration begins to change after

three or four years, but they don't reach full maturity until about six years old. Their long, featherless heads make it easier for them to eat.

Long ago, California condors soared over much of the western United States. By the 1800s, their numbers had dwindled, and they were mostly found in California—which is how they earned their name. Sightings were occasionally reported in other portions of the Southwest, including Utah. Habitat loss, lead poisoning, poaching, power-line accidents, and DDT contamination took a deadly toll.

In 1987, the world's 22 remaining California condors—all living in the mountains above Santa Barbara, California—were captured and held in captivity. Today, more than 347 condors exist in the wild. All are numbered. The lower the number, the older the bird.

A captive breeding effort at the San Diego Animal Park and Los Angeles Zoo helped the condors avoid extinction. Each wild condor is outfitted with a visual ID tag and at least one radio transmitter. Some birds are also given GPS transmitters, allowing biologists to track the flock's movements and behaviors using radio telemetry and GPS mapping.

In 1992, condors were reintroduced to the wild in California. There are now approximately 500 California condors in existence. Over half of those birds are flying free in parts of Arizona, California, and Utah. Condors are now producing chicks in the wild. The birds are protected under the Endangered Species Act and the Migratory Bird Treaty Act.

In the wild, California condors may live up to 60 years. They mate for life and are attentive parents. Around the age of six, condors begin looking for a mate. Like many birds, males attract their partners through highly ritualized mating displays.

Female condors typically lay a single egg on the floor of a small cave or crevice in the face of a cliff. Both parents help incubate the egg, which takes about eight weeks to hatch. If the first egg fails, a second is often laid. After the egg hatches, the young condor remains in its cave for 2–3 months. Most condors take their first flights around six months old.

Juvenile condors are cared for by their parents for a full year—and sometimes longer. Because the adults invest so much time in raising young, wild condor pairs typically rest nearly every other year.

The first California condor chick produced in Utah by the reintroduced population hatched in Zion National Park in 2014. Unfortunately, it did not survive. The same pair of adult condors produced at least one additional chick in Zion in 2016. However, the adult male died later that year due to lead poisoning, and the female was unable to raise the chick alone. In 2018, a California condor finally successfully fledged a chick in Utah.

Another chick was produced in Zion in 2019.

California condors are one of the largest members of the vulture family. They are scavengers that feed on dead animals and often travel more than 200 miles per day in search of food. They feed primarily on large mammal carrion—like deer, sheep, elk, and cattle. They also sometimes feed on smaller carrion like rabbits, hares, and coyotes. Despite their eating habits, condors bathe frequently and spend much time preening their feathers.

Unfortunately, condors aren't too







We love him with every breath forever and for always, remembering him every day for the rest of our lives. We are grateful that the constant and grueling physical pain he carried is now gone. Tristin Edward Vandall, 22, of Cedar City, Utah, tragically passed away on July 31, 2025, in a vehicle accident near Modena, Utah.

Born to Troy and Melani (Garsjo) Vandall on November 14, 2002, Tristin came out running—so much so that the doctors sized him up as a three-month-old. Just 18 months later, he was joined by his sister Tarin, whom he fondly called "Baby T." The two shared a close bond that only deepened as they navigated life's adventures on their own paths.

Raised in northeastern Montana, Tristin developed a deep appreciation for the outdoors through time spent with his dad, Grandpa Larry, and close friends. From early deer hunts to harvesting a bull elk solo during his first archery season, he embraced nature with grit and independence. picky about their meals. They eat everything, including lead ammunition fragments left in hunted animal carcasses. Several studies have shown that lead poisoning is the leading cause of death in California condors, accounting for more than 50 percent of all known mortality. It's also the biggest factor slowing the species' recovery.

#### Removing Lead From Condor Country

Since reintroduction began, dozens of condors in California, Arizona, and Utah have perished from lead poisoning. If the poisoning isn't severe, biologists can capture the condors, treat them to lower their lead levels, and return them to the wild. However, this is a time-consuming and expensive process.

Lead-based ammunition, which is not always clearly labeled, is still available for purchase in stores and online.

With lead poisoning being the leading cause of condor deaths, many hunters have stepped up and switched to

non-lead ammunition to protect the species. Help sustain this amazing bird by doing the same.

#### Seeing Condors in Utah

Although they often winter in Arizona, many condors from the southwestern population now numbering over 93—soar over Utah. They began nesting in Utah in 2014 and can travel back and forth between the Grand Canyon and Zion National Park in a single day. A small population stays in Utah year-round.

While the condors are expanding their territory, Zion National Park still serves as home base for many. The birds are present between April and November, and the best time to see them is in the summer. They are frequently seen perched on or soaring around Angels Landing, the Kolob Road, and up Right Hand Canyon in Cedar City. They have also been

spotted at Cedar Breaks National Monument, Bryce Canyon, and Vermilion Cliffs.

If you see one of these magnificent birds that got lost in time:

Take a picture—or several. These enormous, majestic birds date back to prehistoric times and are not yet safe from extinction.

Keep your distance and do not feed condors. This helps prevent unsafe

human-condor encounters.

Do your part to keep California condors a little further from the edge of extinction.

aturday mornings in Canyon Park West have taken on new meaning over the past vear. At 8 AM each Saturday locals have gathered for a free, weekly 5-kilometer (about 3 miles) event that welcomes runners, joggers, walkers, volunteers, and even dogs.

This month, the parkrun community is prepared to celebrate the one-year anniversary of Cedar City's first, and Utah's only parkrun: Coal Creek Trail. "Over the past year, 495 people have participated in Cedar City's parkrun, ranging in ages from 3 weeks to 83 years," shared Bruce. "It has been great to see familiar and new faces each week."

'parkrun tourists' have joined us from Canada, England, Scotland, Ireland, South Africa, Australia, New Zealand as well as from different parts of the U.S. have all come and enjoyed Cedar City's beauty. "People have joked that we are first parkrun, and tour guides, second" smiled Bruce. "We like to recommend shops, places to eat, and things for visitors to see. That's easy to do, since we love Cedar City."

To celebrate one year of Coal Creek parkrun, organizers are hosting a special anniversary event on Saturday August 9 at 8:00 AM in Canyon Park West. Festivities include extra high-fives for first timers and regulars, post-event light breakfast of fruit, yoghurts, juice and, of course, a birthday cake, courtesy of Cedar City Events. "The city has been great support," added Bruce. "Brandon Burke

helped us to get up and running, and it is great when he joins us for at parkrun."

parkrun is free thanks to the support of volunteers and national sponsors. Over the year, 57 people have volunteered Cedar City's parkrun, doing roles like course set-up, time keeping, updating our "socials", and more. ## Chemistry key for CV football

As he enters his fourth season as head coach

of the Canyon View football team, Burke Miller has led the program to 23 wins over the previous three seasons. After finishing 6-6 in 2024 capped by a quarterfinal loss to eventual 3A champion Morgan in the 3A playoffs, the team has put in the work to build up better chemistry.

And Miller has taken notice with the 2025

season opener set for Aug. 15 at home against the Jordan Beetdiggers.

"The vibe with our football team is really good, the best it's been," Miller said. "The team has each other's backs. It doesn't matter if you're a sophomore, freshman... the camaraderie between the boys has been awesome. Probably the

best offseason we've had, and that's saying something."

Not only will the Falcons face the usual full plate of challenges from the likes of the Trojans and Richfield Wildcats, the Cedar Reds are joining the mix in 3A South for at least the next two seasons. The annual cross-town rivalry battle for the pick-axe trophy takes place at Eccles Coliseum on Oct. 3.

"We like the fact this game will happen later in the season," Miller said. "Whether you want to say it's just another game or not, it's a rivalry game. It's got a different energy to it."

The Falcons will have a quartet of seniors serving as team captains, including Colt Rushton (defensive end and offensive tackle), Cooper Urie (defensive end, linebacker) – a player Miller called "a hybrid we'll be able to move around" - Hudson

Springer (defensive tackle, tight end) and Ryder Miller (quarterback, safety). As has been practice for his tenure as coach, Miller will include junior captains in the mix with the intention of watching them evolve as football players and teammates.

"6-6 last year wasn't good enough for us," Miller said while noting the win total ranked third-best in CV school history. "For us, it felt like a wrecked season because we didn't accomplish our goals. When we talked to our kids about what's expected, the first thing

> they said was 'we're expecting to win."

"They did a great job of leading the team in the offseason, and we made the right decision on them," Miller said.

With the new realignment, it led to several unexpected scheduling challenges for CV. After the home opener against Jordan, the Falcons will only get three other games – two on its own field and the Cedar game at Eccles – in front of a hometown crowd.

"With all the realignment this year, we actually had a set schedule with five home games, but some teams backed out of games very late," Miller said. "Now we're on the road for six games. We're not afraid to go on the road, but it's a bummer for our fans to not see us that one extra time."

In addition to the home games against Jordan and Cedar, Canyon View will host North Sanpete on Sept. 12 and Juab on Sept.

### Realignment in full effect

realignment firmly in place, there are plenty of highschool sports changes to discuss. We've already shared that Canyon View and Cedar will be together as football rivals in 3A South, but there's more within the rest of the fall sports to note. Change can be

hard, but here's what you can expect.

Across all other sports, Canyon View will remain in 3A,



but play in Region 14, which has only five teams. After being moved from Region 12, the Falcons are joined by Delta, Juab and Richfield and Providence Hall. Cedar will stay put in Region 9, joining all the Washington County schools, including Crimson Cliffs, Desert Hills, Dixie, Hurricane, Pine View and Snow Canyon.

Parowan remains in 1A South for football with Kanab, Enterprise and Beaver, and all four schools will play in Region 18 for all other sports with Grand, San Juan and South Sevier.

Girls soccer opened play Aug. 5 as Canyon View traveled to Manti for a non-region game, then traveled to Stansbury on Aug. 7. CV will return home and host Grantsville on Aug. 8 in a 3:30 p.m. kickoff.

The Falcons were 15-4 overall in 2024 and shared the Region 12 title at 13-1, but lost to Ogden, 7-0, at home in the 3A playoff quarterfinals.

Cedar opened its 30th season under head coach Scott Kamachi with road games at Alta on Aug. 7 and Murray on Aug. 9. The Reds are coming off a 12-7 overall record in 2024 and 7-5 in Region 9 that ended with a second-round road playoff loss at Park City.

In girls volleyball, Canyon View is the defending 3A state champion for the first time after finishing 30-2 overall. The Falcons will bring a 17-game winning streak into the season opener Aug. 8 at home against the Crimson Cliffs Mustangs in a 7 p.m. start.

Cedar volleyball starts its season Aug. 12 with a home game against Richfield at 6:30 p.m. The Reds were 16-17 overall in 2024 and 9-3 in Region 9, finishing with a 2-2 record at the 4A state tournament.

In boys golf, Canyon View will play the 3A state tournament at Stansbury Golf Club on Oct. 8 and 9, while Cedar plays the 4A tournament at Lakeside Golf Club in West Bountiful.

-In a season that can only be

described as historically awful, the Colorado Rockies pulled a major-league ray of sunshine out of its collective cap and produced a comeback to remember

on Aug. 1 at Coors Field.

The Pittsburgh Pirates led 9-0 before the home team had its first turn at the plate. They led 15-6 after scoring four runs in the fifth inning and added one more in the sixth to lead the Rockies, 16-10.

It wouldn't be enough.

Colorado would score two runs in the eighth, then put the hammer down by scoring five in the bottom of the ninth – the last two coming on a Brenton Doyle home run with one out – and completing a ridiculously improbable and totally insane 17–16 victory.

With the victory, the Rockies are still 29-80, which is only two games better than last year's Chicago White Sox after 109 games played. The White Sox went on to finish 41-121, and the Rockies could challenge that mark with 14 games (seven each) still to come against the NL West-leading Los Angeles Dodgers and San Diego Padres. So far, Colorado is 1-11 against their division rivals.

Getting 13 wins over the final 53 games may seem daunting, but as long as Colorado doesn't go on a losing streak of any major length, it'll feel a whole lot better than ending up in the record books for the worst season of the modern baseball era.
